Initial presentation on local racial disparity data in the child welfare system Vicki Tylka presented a detailed report including comparisons of data from other counties of comparable size to Marathon County as well as statewide results. The information highlighted the number of child maltreatment reports from the community and partners sorted by race compared to population. Marathon County DSS, as the child welfare agency, then applies standards for screening in or out of the reports and local data was provided by race for this measure. Additional information will be researched regarding other local measures, such as substantiation rates and out of home placement rates. In addition, the Department of Social Services continues to consult with the Department of Children and Families to further interpret data, and begin to strategize around how to address disparities. Vicki answered board members' questions about the information presented.
