4. Educational Presentations and Committee Discussion:

- A. Update on Grant Funded/Assisted Broadband Projects There was a request to update the task force when various places go live.
 - 1. Charter Celeste Flynn shared a map of what they have completed at this time, upcoming dates, and passings. The map will be forwarded to the task force.
 - 2. Frontier Todd Kruse gave an overview of updates coming for release. They will be starting construction on September 1, 2023 and have two years to complete it.
 - 3. Bug Tussel Information update was provided in the packet.
- B. Broadband Support Position Update Gerry has worked with HR and hope to have it posted soon.
- C. Fabric Map Challenges Corp Counsel sent concerns regarding open records law. We continue to wait for a response.
- D. Broadband Equity, Access, and Deployment (BEAD) State Funding and Planning The state will be receiving funds for broadband expansion. The press release was sent out regarding the WISER survey with 158 responses from Marathon County.

5. Policy Discussion and Possible Action:

- A. Broadband Equity, Access, and Deployment (BEAD) Program
 - 1. Identification of Unserved and Underserved Areas Discussion of map, what the codes mean, and how can we partner with ISPs to target the areas.
 - Identification of Barriers Discussion included meaningful participation, financial means, complacency, frustration of speed of results, poor customer service, topography, geography, terrain, and accuracy of current data. Additionally, notifications of the type of service coming and who the service providers are for each township.
 - 3. Identification of Opportunities Discussion included use of the BEAD funds, press release with

positive movement information, presenting realistic timeframes, and a formal presentation to the board with comprehensive overview that can be placed on the website.

B. Process for determining priorities for future broadband expansion efforts – pull the information and maps together as well as capturing the plans of the ISPs moving forward.

The numbers are constantly changing a little bit as things get refined and challenges resolved, but here's a summary table to make things easier for you from the May 30 refresh of the National Broadband Map. Note that these are BEAD definitions of service, which are 100/20+ by a wireline or licensed fixed wireless for **served**, 25/3 to 100/20 by wireline or licensed fixed wireless for **underserved**, and less than 25/3 by wireline or licensed fixed wireless or unlicensed fixed wireless or unlicensed fixed wireless of any speed for **unserved**. Sum no coverage and unserved for the actual total unserved amount. "BSL" is a <u>broadband serviceable location</u>.

Dear County Broadband Partner,

I am happy to announce that registration for our four regional broadband workshops is now open. *Maximize the Impact* of *BEAD Funding: Planning and Partnering Toward Internet for All* workshops are being organized by UW- Madison, Division of Extension's Community Development Institute in partnership with Wisconsin Counties Association, Wisconsin Broadband Office, Wisconsin Economic Development Corporation, Wisconsin State Telecommunication Association and Northwood Technical College.

The goal of the 2-day workshops is to help counties best prepare to access BEAD funding through planning and partnering. Wisconsin Counties Association President and CEO Mark O'Connell will address the role of County Government in Broadband. Staff from the National Telecommunications and Information Administration and the Wisconsin Broadband Office will explain timelines and next steps for BEAD and DE (Digital Equity) funding. Extension staff will provide resources on broadband economics, developing public private partnerships, planning tools and financing options for communities. Legal staff from WCA will discuss considerations counties should make when entering broadband partnerships and resources available through the association. We are working to secure Internet Service Providers for the second day of the workshops for county consultations. A copy of the 2-day agenda can be found at:

It is our hope that every county will participate in one of the 2-day workshops. It would be beneficial for counties to attend as a team so they can strategize on their local plans. Attending regional workshops is an allowable expense through your BEAD planning grant.

The four 2-day regional workshops will be held:

- September 6-7, Northwood Technical College in Rice Lake
- September 28-29, Cranberry Country Lodge in Tomah
- · October 9-10, Radisson Hotel in Fond du Lac
- · October 25-26, Nicolet College in Rhinelander

As part of the registration process your team will be asked which internet service providers you would be interested in having a conversation with. We will do our best to schedule meetings between providers and counties at the event. The earlier your team registers the better the opportunity we will be able to schedule the appointments you desire.
