
The purpose of this handout is to provide information regarding the proposed improvements, describe the potential impacts it would have on the community, and offer an opportunity for public comment.

Project location

The project is located on Pleasant Road bridge over the east branch of the Yellow River in the town of Spencer.



Project purpose and need

The existing single span bridge (P-37-0916) is a single span steel girder bridge with a concrete bridge deck. The bridge was constructed in 1947 and is deteriorated throughout the structure with cracking and spalling (breaking) concrete. The existing steel railing does not meet modern safety standards.

The existing bridge has reached the end of its useful service life and cannot be economically rehabilitated.



Existing Bridge


Proposed improvements

The project is programmed as a bridge replacement project. The town of Spencer has received federal funding through WisDOT to replace the bridge. The Marathon County Highway Department is administering the design process on behalf of the town.

Proposed improvements include:

- Construction of a single span concrete slab span bridge approximately 48-feet long.
- Reconstruction of approximately 160-feet of roadway approaches.
 - 50-feet of each approach would be paved with asphaltic surface to provide a smooth transition to the bridge and keep roadway aggregate off the bridge.
- Place riprap (stone) to prevent erosion along the river.
- Minor right of way and temporary easements are required to replace the bridge.

Traffic impacts

- Construction is currently scheduled for 2025.
- Work will occur after June 15 due to in-water working restrictions.
- The bridge will be closed for approximately 3 months.
- Local access to property owners and emergency services will be maintained from Mann Road (north of bridge) and County Y (south of bridge).

Real estate impacts

Narrow strips of additional right of way will be required for this project. This will include areas of permanent (fee) at select locations and temporary (temporary limited easement) land acquisitions to accommodate blending of slopes on the roadway approaches and matching driveways.

Estimated right of way impacts are shown above. Marathon County expects to begin real estate acquisition in early 2024.

Direct mailings and coordination will occur with impacted property owners. A landowner rights brochure is available for review.

Schedule

- Initial data collection and design development summer/fall 2023
- Local officials meeting January 2024
- Public involvement comment period January 2024
- Preliminary plans and reports approved winter 2023
- Environmental document winter 2023
- Right of way acquisition spring and summer 2024
- Final plans August 1, 2024
- Construction summer 2025
