





Dear Ms. Williams-Stinson:

This letter serves as notice that the Public Service Commission of Wisconsin (Commission) has suspended reimbursement for grant award ID 393, the Clark, Lincoln and Marathon Counties Project, effective January 31, 2024.

Pursuant to the Commission's Order (<u>PSC REF#: 444257</u>) dated July 28, 2022 in docket 5-BF-2022, the Commission approved an award of up to \$4,293,662.00 to the Grant Recipient for eligible activities related to the Clark, Lincoln, and Marathon Counties project as described in the submitted application (<u>PSC REF#: 432963</u>). On October 25, 2022, a grant agreement was executed outlining the terms of the award.

Per Section 22 of the grant agreement, the Commission has authority to suspend payment for cause and upon notice. The Commission provided Frontier notice via email on January 31, 2024, and this letter serves as a formal notice documenting suspension of payment. Due to a factual error in Frontier's grant application, and Frontier's indication that it intends to pursue a reduced project scope, staff find cause to suspend payment, per the terms in the agreement. The Commission will not reimburse any costs incurred after January 31, 2024 until further notice.

The Commission requires additional information to review the application error and proposed reduction in project scope. Please provide a written response to the questions below by Monday, February 26, 2024. Frontier's response should include the original numbers and answers to the questions. Please upload the response and any supporting documentation directly to the Commission's Electronic Records Filing (ERF) system under the docket 5-BF-2022 and use the document type Data Request / Response. When uploading the document, the ERF description must be "Response-Data Request-PSCW-AK 1."

This letter serves as Frontier North Inc.'s ("Frontier") response to the Public Service Commission of Wisconsin's (Commission) request for additional information related to the data error Frontier identified in its grant project ID 393 ("Marathon A"). Frontier apologizes for the address duplication and has instituted safeguards to prevent the unlikely recurrence of an error of this nature, detailed below, all of which were in place when Frontier's filed its grant applications on November 7, 2023. To remedy the error, Frontier respectfully requests that its grant be revised to 6,889 locations and its awarded subsidy be reduced by \$1,000,000. If revised, the Marathon A project will still provide the community benefits initially envisioned, consistent with the broadband grant program, and enable Frontier to expand fiber through its complementary investment to thousands of additional County residents.

Frontier has conferred with Marathon County officials and the County supports the continuation of the project with the proposed revision. Frontier is also continuing to work with Marathon County to mitigate the inaccurate or duplicative addresses within the project.

Frontier Response: Due to the passage of time, limitations of the former consultant's planning model, and the availability of material, among other factors, the cost of the Marathon A project has increased significantly since Frontier submitted its grant application. As specified below, to complete the revised project, Frontier would be contributing nearly three times (295%) the funding it originally committed. The Marathon A project would bring fiber to the premises broadband to a corrected 6,889 locations, as well as close to 4,000 additional synergy locations. Removing the duplicate addresses does not change the overall planned routes/fiber miles.

UPDATE ON PSC CAPITAL PROJECT FUNDS GRANT APPLICATIONS

In the fall of 2023, the PSC facilitated the Capital Projects Funds Broadband Infrastructure Grant Program with the goal to increase broadband internet throughout the state. There were 124 applications requesting \$221.6 million for available grant funds of \$43.2 million.

A total of five applications were submitted for Marathon County. Charter/Spectrum submitted two grant applications for rural areas central/west areas of Marathon County. Frontier submitted three applications for areas in North Central, Central and SW areas of Marathon County.


While the grants scored well, the applications for Marathon County were not selected for funding. A map and list of awarded grants are attached.

Executive Summary

The Wisconsin Broadband Office and its partners formed this Wisconsin Digital Equity Plan by engaging communities through targeted outreach, gathering data, and conducting analysis to understand the unique needs of Wisconsin's covered populations. While this plan is rooted in data and analysis of digital equity needs, it is also centered around stories and direct experiences of Wisconsinites engaged through this outreach. A deeper understanding of communities' needs and barriers to digital equity informed a digital equity vision and mission, supported by more detailed values that guide the goals of this plan.

The Wisconsin Digital Equity Plan sets an ambitious vision to make sure all Wisconsinites will have equitable access to affordable broadband service and the capacity to fully engage in a digital society as the foundation of the plan. The mission coalesces around five core values that capture the many pieces that are needed to achieve true digital equity across the state. The values that frame the plan are:

Access: Expanding high speed internet access to every residence, business, and institution in the state.

Affordability: Ensuring broadband and key digital services are affordable for all.

Adoption: Ensuring all residents can connect to the internet, with the appropriate accessible, internet-enabled devices, skills, information, and services specific to their needs in real time.

Trust: Providing readily accessible resources and supports to build trust with communities and ensure all feel safe when accessing the internet.

Sustainability: Supporting intentional activities and investments for ongoing device access, digital skills education, and affordable broadband subscriptions.

For each of these values, targeted goals objectives, strategies and metrics were crafted to address specific digital equity gaps in Wisconsin. This includes both short- and long-term goals that are adaptable, knowing that digital equity needs are ongoing and evolving. The goals and objectives can be applied to each covered population, although not always to the same extent, particularly the strategies employed to achieve these goals will not be the same across all cover populations. Strategies will be different but the need for these strategies to be embedded in the community and culturally relevant to populations was a notable similarity across all covered populations. While targeted strategies to reach goals for each covered population will be different, the following overarching strategies have been identified to guide this digital equity plan:

- 1. Engage new stakeholders and grow existing partnerships to expand the Wisconsin Digital Equity ecosystem.
- 2. Develop programs and activities to support and compliment the Digital Equity Plan strategies.

The Broadband Office identified existing digital equity assets across the state that can support this work. These assets are vital to the success of the plan and are considered partners in this work. Many of these assets were instrumental in outreach efforts to covered populations.

This Digital Equity Plan has been carefully aligned with Broadband Equity, Access and Deployment (BEAD) program, specifically the <u>BEAD Five-Year Action Plan</u>. As digital equity work progress and needs evolve, the broadband office will ensure ongoing alignment with BEAD and other broadband-related efforts in the state to achieve Internet for All Wisconsin.


