The petition requests a recount of the City of Schofield and Village of Weston Ward 6 for the office of County Board Supervisor. The filing officer has reviewed the petition. 2. The Board of Canvassers convene at 9:00 a.m. on Friday, April 11, 2024 in the Assembly Room of the Marathon County Courthouse, 500 Forest St, Wausau, to begin the recount.
3. The recount be completed by the Board of Canvassers immediately.
4. The clerk transmit a certified canvass report of the result of the recount and a copy of the minutes of the recount proceedings to the Wisconsin Election Commission immediately after the completion of the recount.

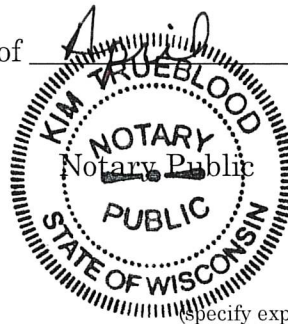


