Marathon County's overarching goal is to be the healthiest, safest, and most prosperous county in Wisconsin. Recognizing that access to broadband is an integral component of County health and prosperity. Marathon County established Goal 8.7: Strive to provide affordable, reliable, high-speed internet access throughout the County in the Strategic Plan 2018-2022.

Mission / Purpose: Develop recommendations identifying the potential role of Marathon County in facilitating the expansion of Broadband access in Marathon County. ### **Broadband in Marathon County**

Marathon County is the largest county in the state of Wisconsin (1,545 square miles) and the 10th largest in population (137,958 according to 2022 US Census Bureau data).

According to 2023 federal data, Marathon County has approximately 15,000 addresses that have no or very slow internet access. 43% of Marathon County residents live in rural areas. Rural broadband presents a unique challenge, as the cost of running infrastructure to rural locations is high.

Marathon County has been working to expand internet access since 2009. We continue to work with county residents, community leaders, the state of Wisconsin and internet service providers to find ways to improve internet access in the County. Our goal is to ensure every address in Marathon County has access to reliable and affordable internet access.

We accomplish this by working with Internet Service Providers (ISPs) in Marathon County to identify areas of need and coordinate the ISP efforts to seek federal and state funding to expand internet service to these areas.

Since 2014, the state of Wisconsin has provided 11 statewide broadband grant initiatives and the Federal Government has funded 2 grant initiatives – resulting in over \$300 million broadband investment in the state of Wisconsin: <a href="PSC Broadband Grant Programs">PSC Broadband Grant Programs (wi.gov)</a>.

It is an enormous and important initiative, somewhat comparable to early 20<sup>th</sup> century efforts to bring access to electricity to every address in the nation. And while these efforts take time, we are making progress. According to the Public Service Commission, there are 56,293 broadband serviceable locations in Marathon County. However, 14,116 addresses remain un- or underserved.

#### MARATHON COUNTY BROADBAND EXPANSION TIMELINE

2024 Coordinating with rural communities, internet service providers and the PSC to identify broadband needs and maximize funding opportunities.

Launched **Broadband page** on Marathon County website.

Began preparations for upcoming Broadband Equity, Access, & Deployment funding which will bring \$1.05 billion to the State of Wisconsin to reach unserved and underserved locations through PSC BEAD grants.

Hired Broadband Coordinator to coordinate efforts for BEAD and ongoing broadband projects.

Worked with Charter and Frontier to submit 5 PSC Grant applications for coverage in Western and North Central Marathon County. None of the grants were awarded funding.

- 2022 Broadband Task Force and County Board coordinated with ISPs (Cirrinity, Bug Tussel and Fronier) in submitting three applications to the PSC for Broadband Expansion Grants. Frontier and Bug Tussel were awarded funding.
- Marathon County participated in a multi-county coalition partnering with Bug Tussel to obtain access to funding with a County guarantee. Bug Tussel's plan includes approximately 190 miles of fiber and 16 towers. Target completion at end of 2024.

Charter and LTD advance in the application process under the Rural Digital Opportunity Fund through the FCC. Charter was selected and the project is ongoing target date of completion is 2025.

\$250,000 of the County's Capital Improvement Program fund was designated in the 2021 budget for broadband expansion.

Partnered with 4 ISP's on 5 Public Service Commission (PSC) grants. One grant was awarded to the Norrie and Pike Lake area.

Partnered with Charter on a \$20 million NTIA Grant Application to serve the eastern portion of the county. The application was not selected.

2020 Broadband Task Force created.

Met with Internet Service Providers.

Broadband Assessment and Plan completed by Design Nine.

This is the Order authorizing a limited reopening of the Order in this docket pursuant to Wis. Stat. § 196.39 to consider changes as summarized below. This limited reopening is to provide notice of the Public Service Commission of Wisconsin's (Commission) intent to modify the Order as to project scope and budget of the grant award approved for the Frontier North Inc. (Frontier) Clark, Lincoln, and Marathon Counties project, and to provide any interested persons an opportunity to comment on the proposed modifications. This limited reopening is exclusively for the project scope and budget associated with that grant award and no other grant award approved in that Order is impacted.

On July 28, 2022, the Commission issued an Order approving \$124,967,392 in Broadband Expansion Grants to 71 projects in the Commission's tenth program round. (PSC REF#: 444257.) The Broadband Expansion Grant program is authorized by Wis. Stat. § 196.504 and in this round, funded by the State of Wisconsin through Wis. Stat. § 13.48(30). Among these projects, the Commission awarded \$4,293,662 to Frontier for its Clark, Lincoln, and

Marathon Counties project. (*Id.* at 29.) The Commission approved Frontier's Clark, Lincoln, and Marathon Counties project based on the description provided in the application. (*Id.* at 26, stating: "Each grant award approved by this Order is for the specific project described in the grant application, at the stated project cost and in the project-area described by the project maps and other document in the grant application.") Frontier's application stated that the project would pass a total of 10,696 locations (812 business, 9,884 residential) including 10,044 unserved locations (755 business, 9,289 residential). (PSC REF#: 432963.) A grant agreement with Frontier, incorporating a project scope based on its application for the Clark, Lincoln, and Marathon Counties project, was executed on October 25, 2022.

Since the Order and execution of the grant agreement, Frontier has determined that its project will only serve 6,889 total locations, including only 1,642 unserved locations. (PSC REF#: 493056, response to PSCW-AK-1.3.) Specifically, Frontier has determined that 3,220 of the total 10,696 locations identified in the application were counted in duplicate (*id.*); 175 of the total 10,696 locations identified in the application are now too expensive to serve (*id.*, response to PSCW-AK-1.4); and only 1,642 of the 10,044 unserved locations identified in the application are in fact unserved (PSC REF#: 494490). Frontier attributed the erroneous classification of the unserved locations to a misinterpretation of the location information provided by the consultant that was performing Frontier's grant planning. (PSC REF#: 494490.) Frontier has indicated that it will make improvements and has moved these functions to an internal team to prevent future errors on grant applications. (PSC REF#: 493056, response to PSCW-AK 1.3.)

Meanwhile, Frontier has also determined that overall project costs have increased from \$17,434,650 to \$40,153,408. Frontier attributes this overall change to the passage of time,

limitations of the former consultant's planning model, the availability of material, and other factors. (*Id.*, response to PSCW-AK-1.2.)

Frontier has reported that construction for the project has not started, but estimates that the project was 20 percent complete based on project planning and development work that has occurred to date. (PSC REF#: 499194.) Frontier requests that the Commission revise its grant agreement to correct the funded locations to 6,889 and reduce the grant amount by \$1,000,000. (Id., response to PSCW-AK 1.5.) Frontier asks the Commission not to make a pro-rata reduction because it is willing to contribute \$23.7 million more than originally committed in matching funds, which would increase the total match percentage from 75 percent of total project costs in the original proposal to 92 percent in its revised request. A summary of these project changes is provided in Table 1.

Based on the information provided by Frontier, its request for scope modification appears reasonable and this draft order proposes to modify the Commission's original Order to reflect the request. While the revised scope would reduce the number of locations served, the proposed reduction in grant funding and increase in match funding is responsive to the reduction in scope, and proceeding with the existing project would allow locations still within the scope to obtain broadband access in a more timely way than they could through separate projects yet to be

initiated. However, the Commission requests additional evidence or comment that is relevant to this decision.

The Commission authorizes the limited reopening of this docket for the limited purpose of taking new evidence and public comment regarding the proposed project scope and budget changes. Comments are due no later than Thursday, June 6, 2024, at 1:30 p.m. CT. If no comments opposing the proposed modifications are received by the comment due date, the Secretary to the Commission is directed to sign on behalf of the Commission an Order on Reopening making the proposed changes. If comments opposing the proposed change are received, the Commission delegates authority to the Commissioner delegated for Broadband to issue a Final Decision on Reopening.

#### **Work in Progress Report**

#### **Current Project Status**

Bug Tussel has contracted with Michels Corporation to assist in the completion of the work that was left unfinished by our previous contractor. We are working to obtain local permits (Athens and Wausau) so that we can repair those areas that need to be addressed and begin work on the Leathercamp Project. With Michels on board and discussions regarding a revised design and funding, we believe that 2024 will be a very productive year.

KES had begun a performance audit of the work completed (or claimed to be completed) by our previous contractor. During this audit, we have determined that a portion of the work claimed to have been completed was not. This audit was occurring during the winter months. The audit work was suspended once a significant amount of snow was on the ground which prevented us from completing our work. With the advent of Michels being able to begin work, we will have Michels perform this work as it begins to complete those areas within the county that need completion. 

#### Introduction

The Marathon County Broadband Project being performed by Bug Tussel Wireless ("BTW"), has been delayed due to a number of factors. While there has been a delay, Bug Tussel is committed to completing this county project and the Leathercamp project by the end of 2024.

#### **Background**


BTW and Marathon County entered into a partnership in 2021 via the issuance of \$25 million of bond funding through the Fond du Lac County Bond Program. The proposed project included the construction of 18 cellular towers and 198.33 miles of middle mile fiber at an estimated cost of approximately \$22.5 million. The Marathon County Board approved the Project in 2022 with a target completion year of 2024.

Following issuance of the project, the President of BTW, the Marathon County Broadband Committee Chairman, and the Marathon County IT Director visited various townships in the County to inform local governments of the Project and to gain any feedback and concerns the townships may have. These meetings included many requests by townships for fiber and/or towers to be located in their areas. As a result, the Project scope had increased from 18 towers to 24 towers and from 198.33 fiber miles to 452 fiber miles with no increase in funding.

Initial construction was kicked off as anticipated in 2021. However, it was quickly realized that rock was more prevalent in the county than originally estimated. This caused significant delays in construction as well as an increase in cost of approximately \$3.5 million in the areas the conduit network is currently installed. In parallel, the effects of the Covid-19 pandemic on the material market were significant, causing significant lead time increases and material costs over doubling from original estimates. The expansion of the project, the need for additional rock boring has led to funding challenges.

#### **Current Project Status**

As of the date of this letter, 16 towers have been constructed and are live, and an additional 7 tower projects are in various stages of lease acquisition and permit approval. Over 182 miles of conduit have been installed. We are verifying that all work has been completed by our subcontractors. Still, the project, which has expanded from the original plan, cannot be completed under the original budget. Bug Tussel has been discussing options to modify the project and its corresponding budget. We understand that there may be concern regarding the completion of the project. Bug Tussel is committed to the Project's success in Marathon County. The setbacks encountered were unfortunate.



- BEAD projects must be completed by end 2030 (6 years or less)






#### **BEAD PRIORITY AREAS IN MARATHON COUNTY**

- Documentation of financial, managerial & operational capacity
- Documentation of other funding received or being pursued.

## PSC Capital Projects Digital Connectivity and Navigators Program

#### **Overview**

The Commission will award up to \$33 million from the U.S. Department of Treasury under the Capital Projects Fund (CPF) Digital Connectivity and Navigators Program to deploy computing devices, install Wi-Fi equipment in targeted apartment buildings, and provide digital navigation services to make use of the devices for work, education, and health monitoring.

## Who is eligible to apply

Non-profits and other eligible entities are eligible to apply for grants. The Commission sub-grant program will prioritize programs embedded within trusted organizations that have capacity and experience with reaching targeted populations.
