- 1. Call to Order and Roll Call: The meeting was called to order by Vice-Chair Werth at 10:33 a.m. Roll call was taken as indicated above.
- 2. Public Comment Period: No public comment.
- 3. Approval of the December 7th & December 8th, 2023, Civil Service Commission Meeting Minutes: Motion by Werth, seconded by Luce, to approve the minutes. Motion carried unanimously.
- 4. Introduction of new Commissioner, Betty Noel.
- 5. Operational Function required by Statute, Ordinance, or Resolution:

c. Review Civil Service Commission Rules – Dave Piehler Dave shared and reviewed the Civil Service Rules and the purpose of the Commission. Accessibility of the Civil Service Commission information page, The Marathon County Code of Ordinances, Deputy and Lieutenant Collective Bargaining Agreements and other informal documentation related to practices and actions of the Civil Service Commission. on the County website.

- 6. Educational Presentation/Discussion:
 - a. Introduction of New Deputies: The Sheriff's Office introduced Brian Modrzejewski and Ed Bauknecht. Each deputy gave a history of their backgrounds and stories. Both Deputies expressed why they decided to join the Sheriff's office was that Marathon County Sheriff's office offers a better opportunity for career advancement, participation in Special Teams (i.e. Bomb, Dive, Swat), a respected leadership staff, relationships with state & federal agencies.
 - b. Sheriff, Billeb gave a "State of Marathon County Sheriff's Office" possible upcoming retirements: Addition of a donated new community K9 Therapy Dog that Deputy Jackie White will receive; Discussed the need to change the Marathon County/Rib Mountain Contract currently staffs 2. Need to add an additional 1 deputy based on the growth of retail. Jail staffing has improved to 9 additional corrections officers with a projection of 15 to be hired by end of year. Sheriff's office created an interagency agreement for the current DA Investigator to transfer to the Sheriff's office as a Deputy Sheriff in the union. This should be completed by year end.
