1. Call Meeting to Order

The meeting was called to order by Chair O'Neill at 8:00 a.m.

- **2. Public Comment** (not to exceed 15 minutes) No public comment received.
- 3. Approval of the Minutes of July 18, 2024, CJCC meeting

- 4. Operational Functions Required by Bylaws None
- 5. Operational Issues
 - A Update on Discussions at Public Safety relative to Treatment Courts and Opportunity for CJCC to Offer a Recommendation for Consideration.

Discussion: Judge O'Neill provides a review of the recent Public Safety meeting discussion regarding OWI Court and law changes. She reviews the efforts to establish a new court population including discussions on Alcohol Court, Family Court, Veteran's Court and DEOJ Court. She states that the stakeholders have been unable to agree on a population. Most recently focus has been on a gender specific court. Sheriff Billeb recommends a motion to continue to support treatment courts and if funding is unused, it can be diverted to address MAT services and treatment within the jail. Gibbs discusses support nationwide for treatment courts and that cutting funding would put us behind the curve on dealing with substance abuse issues. DA Wetzsteon agrees treatment courts have a place in the justice system, but states that programs not run correctly are a liability. She states her position regarding concerns for public safety and asserts that the program must run with public safety in mind, including the specific populations being served and the process relative to identifying a new target population. Questions are asked relative to the ability to retrieve funding if funding is diverted from the courts in 2025. Leonhard provides an overview of the budget process. Chief

Barnes states he supports the concept of Treatment Courts and agrees there should be transparency regarding the costs and outcomes of the program. He states his support for the Marathon County Drug Court and continues to work toward perfection. DA Wetzsteon asks about the process related to unused funds. Leonhard explains that unused funds are returned to the general fund at the end of the year, as opposed to rolling over into the same program the following year. Billeb mentions that MAT must be done with support. Wetzsteon states she supports the treatment concept and wants clarity on reporting program issues. Gibbs discusses getting away from silos and looking at the impacts on programs in other departments. Yarie requests directions on data the committee would like to see ongoing. Billeb offers to set up a meeting to discuss what would be most meaningful. Bootz states that NACO continues to promote treatment courts.

ACTION: MOTION BY BILLEB, SECOND BY BOOTZ, THAT THE CJCC RECOMMEND TO THE PUBLIC SAFETY TO CONTINUE TO SUPPORT FUNDING FOR TREATMENT COURTS WITH ANY UNUSED FUNDS TO REMAIN IN THE BUDGET TO SUPPORT JAIL TREATMENT PROGRAMS. MOTION CARRIED UNANIMOUSLY.

 - A. Update on Jail MAT Program Sheriff Billeb

<u>Discussion</u>: Sheriff Billeb discusses the new requirements of jails to continue MAT for anyone who comes to jail currently on a form of MAT. He states that future grant funds will require all inmates with SUD present must be offered MAT services. These new requirements have led to discussions about adding an additional jail social worker position. He notes that even after grant funding stops, Marathon County will still be responsible for these requirements and increased costs. Billeb further states that he suspects the opioid funding recommendations may present this as an issue for priority. Yarie further states that people leaving the jail on MAT need supportive services to ensure the investment on MAT in the jail is not lost when the individual returns to the community. Billeb agrees that the jail no longer has an obligation when someone leaves.
