The group discussed whether or not municipalities would want to move forward with a public input survey on expansion of transit. Generally, the feedback indicated that the representatives needed to go back to the policy makers in their communities first to gauge interest in expanding transit. The group asked MPO staff to prepare slides and a brief that they could be used to present to their respective boards. The slides and brief should address the major considerations a municipality would need to know related to expanding transit into their communities, including an understanding of potential routes and cost ranges. The MPO staff can use the 2022 Transit Development Plan to provide some of this information, but the group discussed that figures, etc. would likely require more updated study or research, and would be dependent on routes the community would be interested in.

**Follow-Up:** MPO will prepare slides and brief that the participating communities can use to present to their boards and gauge interest. The considerations and figures will be largely based on the 2022 Transit Development Plan.
