

## DSPS Referrals for Alterations of Existing Pools Reference Document

Sanitarians are expected to inquire about past and future pool alterations during each inspection they conduct. During this conversation with the operator, sanitarians should question if any alterations have occurred since the last inspection and/or if any future alterations are planned. This is to ensure any alterations that have occurred meet applicable requirements and to ensure any future alterations will be compliant with ATCP 76, WI Adm. Code requirements. Take the time to explain the applicable requirements to your operators.

The Department of Safety and Professional Services (DSPS) has created the table below to offer clarification. This document is intended to clarify for sanitarians about when a referral to the DSPS is required due to the alterations of an existing pool. This document is not to be used to enforce Chapter SPS 390 code requirements that are not directly referenced in ATCP 76. If the alterations are beyond the scope of Chapter SPS 390 requirements specifically included in ATCP 76, instruct the operator to contact the DSPS Plumbing Consultant, make a referral to DSPS and include a statement in the comment section of the inspection report noting the alteration and referral.

The table provided on the reverse will help determine if/when a referral to DSPS is required.
