B. Administration Work Plan for 2019

Moved to later in the meeting.

Discussion:

Administrator Karger went through his proposed Work Plan for 2019. The Committee made the following recommendations:

<u>Extension</u>, <u>Education & Economic Development</u> – add Work with the UW Officials to increase the student population at the Wausau Campus

<u>Environmental Resources</u> – remove item 4 – Develop a policy and cost share plan to prohibit winter spreading of manure on fields by medium sized producers. Policies are set by the Board.

<u>Health and Human Services</u> – item 7 – Construct a new aquatic therapy pool - timeline to be changed to 12/31/2019.

Jail population and corrections are one of the biggest subjects we need to address now. It's not just a facilities question. We are arresting fewer than we did years ago, but more people are in jail. How do we address this?

Staff wants the plan by strategic priorities. It will get done both ways.

In the future add something with the chamber – make it a living document.

Evaluate pool and fieldhouse or is it evaluate facilities at UWSP? Immediate need is to understand funding requests for the 2 CIP requests – pool and bleacher issues. Bigger issue is how do we assist UWSP successful long term?

C. Real Estate located at 1212 West St., Wausau WI 54401: Recommendation to County Board whether to approve Marathon County's Offer to Purchase Commercial Property, which has been Accepted by Property Owner

6. Educational Presentations/Outcome Monitoring Reports

A. Report from John Robinson and Sara Guild on Wisconsin Counties Association CAP Team meeting held in January 2019, in Madison

Discussion:

Supervisors Robinson and Guild represented the County at the County Ambassadors Program (CAP) meeting. Four main areas were discussed:

- Children and Family aid allocation increase 9.89% County match which has been exceeded for years. Need to align our case load with best practices and stabilize out of home costs
- Secure residential care centers for youth a/k/a/ Lincoln Hills what happens after 1/1/2021 and Lincoln Hills closes. There are still lots of unanswered questions. Governor is seeking up to a two year delay.
- Court appointed attorney compensation rate. Public defender pay for private attorneys is currently \$40 per hour and wants increase to \$100 per hour. County appointed attorneys fees will increase to \$70 July 1 this year and \$100 January 1, 2020.
- Grants to Increase 911 abilities across the state.

Attorney's fees seems to be likely to happen. Full support from attorneys, courts, district attorneys, etc.

Child services is the largest ask ever made. It's not a reactive but more as preventative measure. If we

don't have enough staff, we can only help those currently in the system and we will perpetuate future children and keep them in the system.

Senator Tiffany asked if Marathon County would be interested in having a facility. Currently no counties are interested and if something isn't done to make it more feasible to open a facility, we could end up sending our juveniles to the southern part of the state.

Next CAP meeting is April 2nd focus on health care and possibly revisit Social Services funding requests. *Follow through:*

B. Report on Wisconsin Counties Association (WCA) Legislative Conference held February 5 & 6 *Discussion:*

Chair Gibbs attended the WCA Legislative Conference in Madison. It was a great day and a half of meetings. Governor Evers attended the meetings. Topics centered around Legislative priorities and a more in depth of what the requests are and what the budget might look like. February 28th the Governor will release his budget. 1.1 billion dollars increase in asks than we have which include:

- K-12 funding
- Medicaid expansion
- Preexisting medical conditions
- Clean water wants water quality in the eastern part of the state Kewaunee and south western part of the state
- Dark stores it's a shifting of tax dollars from large stores to the home owners. It's not a lost revenue for the county. It's a shift in where the dollars are coming from. If the trend continues we could see a 5% tax increase. Within a Tax Increment Financing (TIF) It is a delay in collecting and closing TIFs which costs the County money.

GOP Legislators priorities include:

- K-12 funding
- Middle class tax cut different than the Governors
- Clean water
- Maintaining Walker era policy programs

It is unclear on what will happen and what joint finance will do.

Some of WCA's positions:

- Levy limits and levy caps do not keep up with inflation. It was presented that 60 counties had an increase of health care costs
- Conservation staffing and the State's promise to provide funding for conservation staffing they
 have not kept up with this.
- Transportation Where will the funding come from to improve the transportation system and the infrastructure system we have? Legislator are leaning toward tolling. A new committee has been developed with lots of interested parties. Potential increase in gas tax.
- Work Zone safety A priority
- Court appointed attorneys and raise the rate of compensation for counties. Supreme Court sets one rate and the legislature sets the other.
- Protective status for jailers (25 year old policy) If Counties are required to do that and correction
 officers can retire at 55, additional Wisconsin Retirement System (WRS) contributions etc. will
 need to be made. Hold Harmless so employees can enroll in protective status but there will be
 no cost to the county. Employee would pay the additional WRS contributions and any additional
 costs related to that status. WCA supports this as long as there is no additional cost to counties.
- Strain on foster care system Marathon County has been recruiting and our numbers aren't as dire as other areas of the state.
- WCA supports putting 17 year old back into juvenile status, only if fully funded by the state.
