NCHC Human Services Operations Executive Laura Scudiere appears before the committee and answers questions relative to the transfer.

6. Educational Presentations and Committee Discussion

A. Keeping Areas Teens Safe (KATS) – presentation by Mary Jo Freeman relative to the group's local efforts **Discussion**

Dr. Mary Jo Freeman and Bob Stasney appear before the committee to explain the genesis of the Keeping Area Teens Safe (KATS) program locally, indicating that there is significant population of homeless children in our local, Marathon County school districts. Dr. Freeman explains that the group has achieved its 501(c)(3) designation and has worked closely with the United Way and other local stakeholders to address the lack of resources for homeless children in our area.

Dr. Freeman explains that the law permits organizations like KATS to house up to eight (8) homeless children for up to 30 days at any time. Dr. Freeman provides data to the committee to

demonstrate the need for this resource in our community and articulates that the KATS organization is built on successful models from other jurisdictions. Dr. Freeman indicates that the organization has received a grant for \$250,000, with which it was able to secure a physical location. The group is currently working toward securing the appropriate state licensure and is intending to open the home in the last quarter of 2020. KATS is actively seeking grant funding from various sources, including numerous local foundations.

Freeman indicates that it is the intention that referrals to KATS come from "homeless liaisons" within local organizations, schools, the sheriff's office, any other entity, and self-referral.

Freeman and Stasney answer questions from the committee. County Board Chair Gibbs provides a general explanation of the county board budget process, suggesting that should the KATS organization wish to obtain county funds, it make a formal request, in writing, to the Marathon County Administrator.


