## COUNTY ROAD "Y"- SPEED ZONE Town of Plover

**WHEREAS,** modifications are warranted for the speed limits on County Road "Y" in the Town of Plover and


**WHEREAS**, the Marathon County Highway Commissioner and the Marathon County Infrastructure Committee have resolved this issue and concur with the recommendations.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of Marathon does hereby ordain as follows:

- 1. To Amend Section 7.03(4) of the Marathon County General Code to remove the following speed zone from subpart (3) 35 mph;
  - a) CTH "Y". Township of Plover, through Eau Claire Dells County Park, from a point 1.5 miles south of STH 52 southerly for a distance of 0.5 of a mile
- 2. To Modify Section 7.03 of the Marathon County General Code by adding a subpart for a speed limit of 30 mph and renumbering existing subparts (3) 35 mph, (4) 40 mph, (5) 45 mph and (6) 50 mph as listed below;
  - (3) 30 mph
  - (4) 35 mph
  - (5) 40 mph
  - (6) 45 mph
  - (7) 50 mph;
- 3. To Amend Section 7.03(4) of the Marathon County General Code to add the following speed zone to subpart (3) 30 mph;
  - a) CTH "Y". Township of Plover, through Eau Claire Dells County Park, from a point 1.3 miles north of CTH "Z" northerly for a distance of 0.5 of a mile.
- 4. To Amend Section 7.03(4) of the Marathon County General Code to add the following speed zone to subpart (6) 45 mph;
  - a) CTH "Y". Township of Plover, from a point 0.8 of a mile north of CTH "Z" northerly for a distance of 0.5 of a mile.

**BE IT FURTHER RESOLVED;** A traffic and engineering investigation having been made on the described highway, the maximum permissible speed at which vehicles *may* be operated on said highways, which speed is herewith established as reasonable and safe pursuant to Section 349.11, Wisconsin Statutes, **shall** be as set forth herein subject to passage of this ordinance, publication as required by lay and upon the erection of standard signs giving notice thereof:

CTH G Bridge east of CTH Q - Bridge crew began work on this project the first week of June and is anticipated to be completed at the end of August. The crews poured the first abutment, are working on the second abutment, and plan to begin forming the deck in early July. They did have some delays due to high water from the heavy rain two weeks ago.

CTH Y Bridge north of Hatley – Radtke Contractors have poured the decked and has started working on the approaches of the bridge. The asphalt should be in place by the fourth of July. There was an issue with the steel railing anchor bolts and needed some modifications. Contract end date is July 23 and it should be finished a minimum of 1 week ahead of schedule. Note that this was a low risk pilot project last year with WisDot and the contract for design was in early July of 2019 and went through the entire review process and will be finished in 13 months of the signing of the design contract. This is normally a 3 year process.

#### **Paving Projects**

CTH Z (CTH Y - County Line) - Project was completed 3<sup>rd</sup> week of June

CTH Y (CTH Z – STH 52) – Project was completed 3<sup>rd</sup> week of June, including paving the campground loop for the Parks Department; coupling this work with our highway paving saved the expense of mobilizing to the site and took advantage of our asphalt bid pricing.

CTH N (CTH H - STH 107) – Lower layer is complete, surface layer is started. Crews plan to finish the surface layer the week of July 6<sup>th</sup>.

CTH KK (CTH B - Shurwood) - Project scheduled to begin the week of July 6th.

CTH L (CTH S – Deer Creek Lane) – Cold In-Place Recycling (CIR) is complete. Paving planned for late July.

CTH L (STH 107 – CTH O) – Cold In-Place Recycling (CIR) is complete. Paving planned for late July. CTH FF (CTH S – STH 107) – Cold In-Place Recycling (CIR) is complete. Paving planned for late July. CTH S (CTH A – CTH S) – Thin overlay planned for late August.

CTH O (CTH A – County Line) – Thin overlay planned for late August.

Construction crews are working to stay ahead of the paving crew with culvert and ditch work. In July, crews will be working with the Towns of Easton, Berlin, Cleveland and McMillan to complete Bridge Aid projects.

State and Highway mowing for the first round is complete. Crews and equipment worked well to get mowing completed before the fourth of July. Last year we had several equipment issues that impacted the mowing schedule.

County wide culvert inspections are completed. Staff at CPZ is working with a consultant to integrate the information into our county mapping.
