1. <u>Call Meeting to Order</u> – The meeting was called to order by Chair Seefeldt at 1:00pm, Rm. 5, 212 River Dr., Wausau. Official notice and the agenda for the meeting was posted publicly in accordance with State statutes.

2. Public Comment - none brought forward

3. <u>Approve Minutes</u> – **Motion** / second by Maszk / Rosenberg to approve the minutes from the January 31, 2023 regular Forestry/Recreation Committee meeting. Motion **carried** by voice vote, vote reflected as 3-0.

- 4. Operational Functions Required by Statute, Ordinance or Resolution
- A. Discussion and Possible Action by Committee
 - 1. Timber Sale Closeouts

Rodney Hix Forest Products Contract #686-19 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 3360 and 4471.50 tons were cut. Total revenue for this sale was \$46,990.33. Lovlien's recommendation is to close out Contract #686-19 and return their original Letter of Credit. **Motion** / second by Rosenberg / Seefeldt to close out Contract #686-19 and return their original Letter of Credit. Motion **carried** by voice vote, vote reflected as 3-0.

Futurewood Corporation #667-18 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 1830 and 2848.24 tons were cut. Total revenue for this sale was \$56,645.79. Lovlien's recommendation is to close out Contract #667-18 and return their original Surety Bond. **Motion** / second by Seefeldt / Maszk to close out Contract #667-18 and return their original Surety Bond. Motion **carried** by voice vote, vote reflected as 3-0.

2. Review and Consider Approving Spring 2023 Timbersale Package – The spring timber sale package had been distributed to Committee for review. The county forest sales offer 330 acres of timber on four tracts with an estimated volume of 17,720 tons and 528.0 thousand board feet. Tucker discussed the sales and explained how they determine which areas are going to be harvested. The sales will be advertised and the bid opening will be on May 1, 2023. Questions were answered. **Motion** / second by Rosenberg / Maszk to approve and advertise the four spring 2023 timber sales. Motion **carried** by voice vote, vote reflected as 3-0.

3. Review Lake States Forest Management Bat Habitat Conservation Plan Information and Summary – Lovlien explained that bats have been listed as federally endangered on March 31 and the WCFA has been working with the DNR on how to continue to manage the forests. The County can sign on to the Lake States Bat Conservation Plan which is a way to receive incidental take coverage and be sure that Marathon County Forest is in compliance with the Federal Endangered Species Act with respect to the federally listed bat species. County park lands can also be added and enrolled on the same application. The application and/or resolution will be brought back to the Forestry/Recreation Committee and Parks Commission for approval. Questions were answered. **Consensus** by Committee to send in application.

4. 2022 County Forest Division Annual Report – Lovlien discussed some of the program highlights including revenue and expenses, certification, timber management, road and trail management, wildlife management, recreation, public outreach, and professional development. **Motion** / second by Rosenberg / Maszk to accept and approve the 2022 County Forest Division Annual Report and forward to the County Board. Motion **carried** by voice vote, vote reflected as 3-0.

5. Discuss and Consider Approval on Department of Natural Resources Request to Construct up to 30 Exclosures to Compare Oak Regeneration Success – The DNR made a request to construct exclosures in oak dominated County forests to compare the growth due to deer browsing. There is no County financial commitment and the DNR will do all the maintenance on the exclosures which will be in place for a minimum of three years. Staff supports this research and wanted to inform Committee because it involves building something and leaving it in the forests. **Motion** / second by Maszk / Rosenberg to support the DNR research. Motion **carried** by voice vote, vote reflected as 3-0.

6. Discussion and Recommendation from Forest Citizens' Advisory Subcommittee on Hunting and Trapping at Bitzke Birdwalk Nature Trail Between Sept. 1 and Nov. 15 – Lovlien gave history on the Bitzke Birdwalk area. Up until 2019 the area had a wildlife refuge status but DNR removed it unbeknownst to Lovlien which meant that people could hunt and trap there. A decision has to be made whether to allow hunting or trapping in the future. Staff feels there could be some conflicts if it is opened to hunting between Sept. 1 and Nov. 15. They don't want to promote it as a nature trail if hunting is allowed. The Forest Citizens' Advisory Subcommittee made a motion to recommend a county forest ordinance be created to continue to prohibit hunting at the Bitzke Birdwalk Nature Trail between Sept. 1 and Nov. 15, keep it closed to waterfowl hunting year round, and allow trapping during all statewide seasons determined by the Wisconsin Department of Natural Resources. Questions were answered and discussion followed. **Motion** / second by Rosenberg / Maszk to create an ordinance that prohibits hunting between September 1 and November 15 and post signs again. Trapping would be allowed and waterfowl hunting would continue to be closed year-round. Motion **carried** by voice vote, vote reflected as 3-0.

6. Educational Presentations/Outcome Monitoring Reports

A. Forestry Division Expense/Revenue Reports – Lovlien explained the ten-year synopsis showed over that period revenue from timber stumpage was \$820,394.00 over expenses and the nineteen-year synopsis showed timber stumpage revenues of \$1,043,778.00 over expenses. The reports don't include any recreation programs which are tracked in separate budgets. The forestry program is paying for itself with timber stumpage revenues and helps with tax levy relief.

B. 2022 Timber Stumpage Payments to Towns – Lovlien explained that each year the County is required by State Statute to return ten percent of all timber proceeds to towns that have County forests. Lovlien discussed the acreage the towns have and their associated payments. He said it's a payment in lieu of taxes for towns to recoup some of their monies if it was taxable property. The State also increased the acreage share payments from thirty cents to sixty-three cents an acre as well.

C. Wisconsin North Central Forest Health Workshop September 13, 2023 – Tucker was approached to present on oak wilt and oak regeneration on work that has done at Nine Mile as part of the State and Federal forest health workshop tour on September 13th. Lovlien said that any one was welcome to come and listen to the presentation.

D. Information Sign to be Installed at Nine Mile Forest Laurel Road Parking Lot – As part of educating the public, the sign being installed will say entering county forest please remember hunting occurs year-round per state regulations, wear bright colors, respect private property, respect and be courteous to others, dogs must be under control, leashes are encouraged and enjoy the forest. The sign will be installed by April 14 because that date is the first youth turkey season. If dogs get on to private property landowners have the option to contact the Sheriff's Department.

Expiring timber sale: 9-15, Mr. Fudd, Contract 644-15 expiring date extension: 06/30/2023.

Central Wisconsin Lumber would like to continue under contract for the harvesting of <u>timber sale 9-15</u>, <u>Mr. Fudd, contract 644-15</u>. It is our understanding that penalties could be enacted due to the delay we are requesting no penalties be enacted.

Great effort was put into finishing this timber sale this past winter 2022-2023. Opening and freezing the road down repeatedly and twice daily driving the road after initially opening the roads, preparing the extension of the wood's road for logging access. Early December rains followed up by snow, did not allow ground freezing. In January and February repeated rains did not make it possible to continue harvesting the timber sale. The ground was not frozen and trying to track through the forest without timber slashing started proving futile to continue without causing ruts to the landscape. It was decided with the warming and melting of February to leave this timber sale once again to return the following winter to complete the uncut portion.

We are formally requesting that Marathon County send Central Wisconsin Lumber an extension contract for timber sale 9-15, Mr. Fudd, Contract 644-15.

 - A. Discussion and Possible Action by Committee

1. 2022 Forestry / Recreation Committee Tentative Meeting Schedule – Committee agreed to keep the meetings on the same schedule that the Environmental Committee follows which is the Tuesday before the first Thursday of every month. This meeting will continue to be held at 1:30pm.

2. Consider Timber Sale Contract Extension Requests – Lovlien explained that because of Covid, markets, and poor winters there are a lot of timber sale contract extension requests. He discussed each contract, how much work they have completed, and their reasons they submitted for requesting an extension. Lovlien said he usually recommends a one-year extension but is recommending a six-month extension because most of the contracts are winter only sales. **Motion** / second by Seefeldt / Rosenberg to approve six-month extensions at a zero percent increase in stumpage for contracts #678-19, #673-18, #671-18, #668-18, #665-18, #666-18, and #660-17 and if these sales are not completed that any additional extension requests will be subject to stumpage increases following the contract. Motion **carried** by voice vote, vote reflected as 2-0. Lovlien discussed the history, completion amount, and reasons submitted for an extension request on contract #644-15. The sale is six years old. **Motion** / second by Rosenberg / Seefeldt to approve a six-month extension for contract #644-15 at a zero percent increase and if it is not completed this winter 21-22 the sale will be closed out and the purchasers performance bond may be forfeited due to breach of contract. Motion **carried** by voice vote, vote reflected as 2-0.

3. Timber Close Out – Wilson Forestry LLC Contract #702-21 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 2780 and 2708.78 tons were cut. Total revenue for this sale was \$42,240.04. Lovlien's recommendation is to close out Contract #702-21 and return their remaining balance of \$13,859.96 and their original Letter of Credit. **Motion** / second by Seefeldt / Rosenberg to close out Contract #702-21 and return their remaining balance of \$13,859.96 and their original Letter of \$13,859.96 and their original Letter of Credit. **Motion** / second by Seefeldt / Rosenberg to close out Contract #702-21 and return their remaining balance of \$13,859.96 and their original Letter of Credit. 1. Review and Consider Approving the 2022 Wildlife Work Plan – Brandon Stefanski, DNR Wildlife Biologist – The work plan had been previously distributed. Stefanski reported on accomplishments from 2021 and explained the 2022 workplan. Work includes flowage maintenance, dike maintenance, cattail management at the Bern flowage, wild rice seeding, alder and invasive species management, and forest opening maintenance. Stefanski discussed the Nickel-An-Acre budget.

2. Review and Consider Approving the 2022 County Forest Work Plan – Lovlien reviewed the work plan. He gave highlights on upcoming work including timber management, road and trail maintenance, conservation aids projects, administration, GIS work and professional development. **Motion** / second by Rosenberg / Seefeldt to approve the 2022 County Forest Work Plan and forward the Resolution and work plan to the Environmental Resource Committee for their consideration. Motion **carried** by voice vote, vote reflected as 2-0.

3. <u>Approve Minutes</u> – **Motion** / second by Rosenberg / Maszk to approve the minutes from the April 5, 2022 regular Forestry/Recreation Committee meeting. Motion **carried** by voice vote, vote reflected as 3-0.

- A. Discussion and Possible Action by Committee

1. Establish or Confirm Remaining Committee Meeting Dates and Times – **Motion** / second by Maszk / Rosenberg to keep the schedule as the Tuesday before the first Thursday of the month at 1:30pm. Motion **carried** by voice vote, vote reflected as 3-0.

2. Timber Sale Extension Requests

Country Forest Products Contract #682-19 – Lovlien explained the contractor received one free prior extension and has almost one hundred percent of the estimated volume cut. Lovlien recommends giving a second extension at a zero percent increase in stumpage. **Motion** / second by Rosenberg / Maszk to extend Contract #682-19 for six months with a zero percent increase in stumpage. Motion **carried** by voice vote, vote reflected as 3-0.


Denfeld Logging Contract #665-18 - Lovlien explained this sale will be four years old, received two free prior extensions and the contractor has said he is not going to cut the sale with or without a stumpage increase. Lovlien recommends Committee find him in breach of the contract for failure to perform, confiscate his performance bond of \$4,610.00 and not allow him to bid on Marathon County timber for two years per the contract. **Motion** / second by Maszk / Rosenberg to find the contractor in breach of contract #665-18 for non-performance, confiscate his bond of \$4,610.00 and not allow him to bid on Marathon County timber sales for two years. Motion **carried** by voice vote, vote reflected as 3-0.

Futurewood Contracts #667-18 and #670-18 – Lovlien explained these sales were bought at the same time and will be four years old, they both received one free prior extension request. The contractor has cut over one hundred percent of the estimated volume on contract #670-18 but there is an overrun on this job. The contractor has cut thirty-seven percent of the estimated volume on contract #667-18. Options were discussed and questions were answered. Lovlien gave reasons for his recommendation to give a zero percent increase in stumpage on contract #667-18. Motion / second by Seefeldt / Maszk to extend contract #667-18 for one year with a ten percent increase in stumpage fees. Motion carried by voice vote, vote reflected as 3-0. Motion / second by Rosenberg / Seefeldt to extend contract #670-18 for one year with a zero percent increase in stumpage fees. Motion carried by voice vote, vote reflected as 3-0.

Central Wisconsin Lumber Contract #644-15 – Lovlien explained this sale is six and a half years old and has received three free prior extensions and one extension with a twenty percent increase. Lovlien discussed the history of the work that had been done and that ninety-seven percent of the estimated volume has been cut. The contractor would like to finish the job. Committee discussed different options regarding the sale. **Motion / second by Seefeldt /** Rosenberg to extend Contract #644-15 for one year with a zero percent increase and if for some reason the sale does not get completed this winter that it will be closed out and the amount of the performance bond retained will be determined next spring. Motion carried by voice vote, vote reflected as 3-0.

3. Review Timber Bids and Award Contracts – Lovlien reported that bids were opened yesterday and all the sales had bids. There were thirty-two bids on five tracts from fifteen different contractors. The County has worked with all the high bidders previously. He recommends awarding the tracts to the high bidders. Questions were

ICYMI: Gov. Evers Announces Budget Initiatives to Bolster Conservation, Strengthen Forestry Industry

MADISON — Gov. Tony Evers today will visit Milwaukee's Arborist Apprenticeship Program to highlight his 2023-25 biennial budget initiatives to strengthen Wisconsin's forest regeneration and management, take preventative action against invasive species, and expand the forestry industry workforce across the state.

"Conservation is part of our DNA as Wisconsinites, and preserving our forestland and other outdoor spaces is not only important for Wisconsinites' health and well-being but also critical to our state's economic success." said Gov. Evers. "From investing in forestry regeneration and mitigating invasive species to bolstering our vast forestry workforce, these investments are about protecting our environment and growing our economy for generations to come."

<u>According to the Wisconsin Department of Natural Resources (DNR)</u>, the forest products industry in Wisconsin accounts for more than 60,000 jobs and has a total industry output of \$24.4 billion, and for every 10 jobs in the forest products industry, 12 additional jobs are supported in other state sectors.

Over the last four years, Gov. Evers and the Evers Administration have prioritized strengthening Wisconsin's forestry industry and promoting forestry across Wisconsin. The governor's 2021-23 biennial budget increased the County Forest Acreage Share Payments from 30 cents to 63 cents—the first increased investment in more than 30 years. In <u>April 2021</u>, Gov. Evers also signed Executive Order #112, pledging to plant 75 million new trees in rural and urban areas and conserve 125,000 acres of forest in Wisconsin by 2030 in collaboration with public, private, and non-governmental partners. When fully realized Wisconsin's tree pledge will result in nearly 29 million metric tons of carbon dioxide stored over the next 50 years.

Additionally, the governor has previously invested \$4 million each to the Wisconsin Institute for Sustainable Technology (WIST) at the University of Wisconsin (UW)-Stevens Point and the Advanced

Manufacturing, Engineering Technology, and Apprenticeship (AMETA) Center at Mid-State Technical College (MSTC) to support their work to ensure the long-term viability of the state's paper and forest products industry. In addition, the governor previously provided up to \$8 million through the Workforce Innovation Grant Program for the Wisconsin Forestry Center at UW-Stevens Point to invest in their Forest Industry Workforce Recruitment and Development Initiative, as well as up to \$9 million through the same grant program to support construction of the AMETA Center at MSTC.

More information regarding the governor's proposal to support the state's forestry industry, from forest regrowth and resiliency to local county forest administrative support to expanding forestry workforce development programs, is available below.

Conserving and Protecting Wisconsin's Forestry Resources

The governor's budget will continue working toward the goals of Executive Order #112 by providing more than \$4.4 million to encourage the planting and growth of trees and forests, including:

- \$395,000 annually for forest regeneration on state-owned lands, including state forests;
- \$667,500 annually to provide technical and financial assistance to public landowners for reforestation, forest regeneration and management, with a focus on county forests; and
- \$627,800 to support the state nursery program to increase the production and distribution of seeds and seedlings for reforestation.

The governor is also proposing additional funding to support 30 county forests across Wisconsin, totaling over 2.4 million acres available to the public with:

- \$250,000 annually for county forest administration grants and sustainable forestry grants to support county forests; and
- \$128,300 annually to support wildlife habitat management on county forest lands.

The governor's budget proposal also provides \$957,600 to replace fire protection equipment used in combatting forest fires, ensuring firefighters and first responders have the tools they need to safely and effectively battle these fires.

Prevent Invasive Species

The governor is proposing more than \$2.7 million for invasive species prevention. Invasive species degrade natural habitats and make it more difficult and expensive to manage forests, parks, grasslands, and other natural spaces. This investment includes:

- \$589,500 annually for Terrestrial Invasive Species Protection;
- \$310,000 annually for the Resilient Forests Initiative, which provides grant funding to the Wisconsin Forest Landowner and Weed Management Area programs to assist with forest management and invasive plant control on private forest land; and
- \$475,000 annually for urban forestry grants to help communities with forest management, education and outreach, emerging invasive species threats and emergency storm response.

Growing Wisconsin's Forestry Industry and Workforce

Wisconsin's forestry industry is a critical part of the state's economy, but like many sectors, has struggled to attract and retain skilled forestry professionals.


The governor is proposing providing an additional \$500,000 over the biennium in his Executive Budget for both the WIST at UW-Stevens Point and the AMETA Center at MSTC to further support their critical work in building out Wisconsin's forestry and paper industry workforce.

Gov. Evers is also proposing providing \$195,000 to hire an outreach officer to work with groups that are historically underserved by traditional forestry and environmental higher education programs to help expand the pool of interested individuals in this vital industry and ensure the long-term viability of the industry.

Finally, Gov. Evers is proposing providing \$775,000 in fiscal year 2024 for the development of a forestry industry strategic plan and roadmap, which will help to retain existing businesses, identify new market opportunities, and drive innovation. This initiative was first recommended by the Governor's Blue Ribbon Commission on Rural Prosperity.
