# FORESTRY/RECREATION COMMITTEE MINUTES

1. <u>Call Meeting to Order</u> – The meeting was called to order by Vice-Chairman Seefeldt at 1:30pm, Rm. 3, 212 River Dr., Wausau. Official notice and the agenda for the meeting was posted publicly in accordance with State statutes.

2. <u>Public Comment</u> – none brought forward

3. <u>Approve Minutes</u> – **Motion** / second by Rosenberg / Seefeldt to approve the minutes from the March 1, 2022 regular Forestry/Recreation Committee meeting. Motion **carried** by voice vote, vote reflected as 2-0.

4. Operational Functions Required by Statute, Ordinance or Resolution

A. Discussion and Possible Action by Committee

1. Review and Consider Approving Spring Timber Sale Package – The spring timber sale package had been distributed to Committee for review. The sale offers 301 acres of timber on five tracts with an estimated volume of 20,690 tons and 391.0 thousand board feet. Joe Tucker, County Forester discussed all the sales. The sales will be advertised and the bid opening is May 2<sup>nd</sup>. **Motion** / second by Seefeldt / Rosenberg to approve and advertise the spring 2022 timber sale package. Motion **carried** by voice vote, vote reflected as 2-0.

2. Timber Sale Closeouts: Wilson Forestry LLC - Contract #696-20 - A closeout summary was previously provided. Loylien reported that the estimated number of tons was 7450 and 5897.36 tons were cut. Total revenue for this sale was \$64,055.09. Lovlien's recommendation is to close out Contract #696-20 and return their Letter of Credit. Motion / second by Rosenberg / Seefeldt to close out Contract #696-20 and return their Letter of Credit. Motion carried by voice vote, vote reflected as 2-0. Country Forest Products - Contract #687-19 - A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 2325 and 2548.56 were cut. Total revenue for this sale was \$69,606.19. Lovlien's recommendation is to close out Contract #687-19 and return their cash bond. Motion / second by Seefeldt / Rosenberg to close out Contract #687-19 and return their cash bond. Motion carried by voice vote, vote reflected as 2-0. Twin Forest Products – Contract #689-20 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 940 and 1296.52 were cut. Total revenue for this sale was \$18,495.08. Lovlien's recommendation is to close out Contract #689-20 and return their Letter of Credit. Motion / second by Rosenberg / Seefeldt to close out Contract #689-20 and return their Letter of Credit. Motion carried by voice vote, vote reflected as 2-0. Russ Thums Construction – Contract #695-20 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 4920 and 4561.93 were cut. Total revenue for this sale was \$41,735.57. Lovlien's recommendation is to close out Contract #695-20 and return their Letter of Credit. Motion / second by Seefeldt / Rosenberg to close out Contract #695-20 and return their Letter of Credit. Motion carried by voice vote, vote reflected as 2-0. Schreiber Logging - Contract #678-19 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 984 and 1019.71 were cut. Total revenue for this sale was \$23,426.03. Lovlien's recommendation is to close out Contract #678-19 and return their Letter of Credit. Motion / second by Rosenberg / Seefeldt to close out Contract #678-19 and return their Letter of Credit. Motion carried by voice vote, vote reflected as 2-0. Bell Timber - Contract #668-18 - A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 2157 and 2507.54 were cut. Total revenue for this sale was \$48,030.40. Lovlien's recommendation is to close out Contract #668-18 and return their cash bond. Motion / second by Seefeldt / Rosenberg to close out Contract #668-18 and return their cash bond. Motion carried by voice vote, vote reflected as 2-0. Lovlien discussed how well the winter season went and that the department will be close to having record timber sale revenue this year. Most of the contracts that were extended last December were completed. Because there have been two record revenue years, they will be expecting lower revenues going into next year's budget.

# 6. Educational Presentations/Outcome Monitoring Reports

A. Calendar Year 2021 Public Forest Timber Sale Reports – Lovlien discussed two reports, the Sold Public Forest Timber Sales and the Completed Public Forest Timber Sales for calendar year 2021. He said the county, state forests and other state lands make up most of the public land timber sales in Wisconsin. The county forests with their 2.4 million acres are the largest supply of public timber for contractors. This is a significant amount that the contractors rely on from the counties. In 2021, the county forests closed out 45,000 acres and received about 45 million dollars in revenue. The state forests with 1.5 million acres in 2021 closed out 8,000 acres and received about seven million dollars in revenue.

B. Marathon County Solid Waste Timber Sale – This is the fourth timber sale that the Parks, Recreation and Forestry Department has helped the Solid Waste Department with at the landfill. A full forestry service is provided and the Solid Waste Department reimburses time, mileage, and materials. The Solid Waste Department has lower costs versus if they would have to hire a private consulting forester. The Forestry Division while busy this winter, was glad to help. Questions were answered.

C. Update on the Fat Tire Bike Proposal Trial Season – Lovlien explained that last month a concern had been brought up about bikers and snowshoers sharing trails. He was able to work out a compromise on a short section of the trail. If the proposal is approved, this section would be double groomed. The snowshoers will be on one side of the trail and the bikers on the other side so that they can pass freely. That would then give a loop trail for snowshoers that would not be shared. Lovlien noted the entire snowshoe trail is about 6.7 kilometers and of that only about thirty percent would be shared trails. About 4 kilometers of snowshoe trail will not be shared, that is the portion where snowshoers can do a loop and come back to the chalet. The final fat tire bike proposal will be presented to the Citizens Forest Advisory Subcommittee in early June. Their recommendation will be brought to the Forestry/Recreation Committee at the July meeting.

A. Announcements/Requests/Correspondence – Nemec discussed the County time standards that the DNR is providing to Marathon County. He hoped that all members will return on this Committee after the upcoming election. The Environmental Resource Committee may still be changing their meeting dates which could affect the meeting date of this Committee. He was asked to attend the Eastern Towns Association meeting on April 21<sup>st</sup>.

- 1. <u>Call Meeting to Order</u> The meeting was called to order by Vice-Chairman Seefeldt at 1:30pm, Rm. 5, 212 River Dr., Wausau. Official notice and the agenda for the meeting was posted publicly in accordance with State statutes.
- 2. Public Comment none brought forward
- 3. <u>Approve Minutes</u> Motion / second by Rosenberg / Seefeldt to approve the minutes from the October 5, 2021 regular Forestry/Recreation Committee meeting. Motion **carried** by voice vote, vote reflected as 2-0.
- 4. Operational Functions Required by Statute, Ordinance or Resolution

A. Discussion and Possible Action by Committee

1. 2022 Forestry / Recreation Committee Tentative Meeting Schedule – Committee agreed to keep the meetings on the same schedule that the Environmental Committee follows which is the Tuesday before the first Thursday of every month. This meeting will continue to be held at 1:30pm.

2. Consider Timber Sale Contract Extension Requests – Lovlien explained that because of Covid, markets, and poor winters there are a lot of timber sale contract extension requests. He discussed each contract, how much work they have completed, and their reasons they submitted for requesting an extension. Lovlien said he usually recommends a one-year extension but is recommending a six-month extension because most of the contracts are winter only sales. Motion / second by Seefeldt / Rosenberg to approve six-month extensions at a zero percent increase in stumpage for contracts #678-19, #673-18, #671-18, #668-18, #665-18, #666-18, and #660-17 and if these sales are not completed that any additional extension requests will be subject to stumpage increases following the contract. Motion carried by voice vote, vote reflected as 2-0. Lovlien discussed the history, completion amount, and reasons submitted for an extension request on contract #644-15. The sale is six years old. Motion / second by Rosenberg / Seefeldt to approve a six-month extension for contract #644-15 at a zero percent increase and if it is not completed this winter 21-22 the sale will be closed out and the purchasers performance bond may be forfeited due to breach of contract. Motion carried by voice vote, vote reflected as 2-

3. Timber Close Out – Wilson Forestry LLC Contract #702-21 – A closeout summary was previously provided. Lovlien reported that the estimated number of tons was 2780 and 2708.78 tons were cut. Total revenue for this sale was \$42,240.04. Lovlien's recommendation is to close out Contract #702-21 and return their remaining balance of \$13,859.96 and their original Letter of Credit. Stefanski reported on accomplishments from 2021 and explained the 2022 workplan. Work includes flowage maintenance, dike maintenance, cattail management at the Bern flowage, wild rice seeding, alder and invasive species management, and forest opening maintenance. Stefanski discussed the Nickel-An-Acre budget.

2. Review and Consider Approving the 2022 County Forest Work Plan – Lovlien reviewed the work plan. He gave highlights on upcoming work including timber management, road and trail maintenance, conservation aids projects, administration, GIS work and professional development. Motion / second by Rosenberg / Seefeldt to approve the 2022 County Forest Work Plan and forward the Resolution and work plan to the Environmental Resource Committee for their consideration. Motion carried by voice vote, vote reflected as 2-0.

Hi Tom,

We would like extensions on both of our expiring Marathon County timber sales (Garter Snake and Break Through).

I met with 3 contractors this winter to try and get these job done and reached out to others.

All of the timber sales we did work on this winter were expiring/expired. It was not for lack of effort that your sales were not completed.

The industry is still feeling the effects of the WI Rapids mill shut down. It takes quite a bit of time to get back on track when you loose 25% by volume of all wood consumed in the state. This has also lead to depressed delivered rates to the remaining mills. Contractor availability has also been reduced, many loggers have decided to retire or change careers. Inflation on all of the inputs to produce a cord of wood, parts availability, supply chain issues, labor shortage are also not helping.

Anything the Forestry Committee can do to not add any more challenges to the ones we are facing in the woods would be appreciated. A 0% stumpage increase is my request.

I look forward to seeing you at the Forestry Committee meeting to discuss.

Hi Scott,

The Forestry Committee will be meeting May 3<sup>rd</sup> to decide timber sale extension requests. Your crews made good progress on the sale although there still is approximately 55 acres with an estimated 750-800 cords and 50MBF still remaining to be cut and the sale is 6.5 years old. The Forestry/Recreation Committee minutes from November 30, 2021 say that if the sale wasn't completed the winter 21-22 that the sale would be closed out and the bond may be forfeited due to breach of contract. I don't know if the Committee will offer another extension. However, if they would consider an extension it likely would be offered following the contract terms with a 10% increase in stumpage and that it is completed the winter 22-23.

Would CWL even consider finishing the sale with another 10% increase in stumpage? Or would CWL decide to walk away from the sale and negotiate the County keeping part of your performance bond. Again, ultimately the decision rests with the Committee. Please let me know your thoughts by April 22. Thanks, Tom.

## **INCREASED ACREAGE SHARE PAYMENTS**

Wisconsin counties hold significant acreage of lands enrolled under Wisconsin's County Forest Law (State Statutes §28.10 & 28.11). Citizens of Wisconsin value these County Forests because they provide reliable raw materials for the forest products industry as well as public access and recreation programs on more than 2.4 million acres of forested lands. These county forests are a large part of what makes northern Wisconsin unique and collectively make up the largest public forested land holdings in the State.

Currently, the Department of Natural Resources makes Acreage Share/PILT payments to towns for state forest, other state lands and county forests. Payment for county forest lands is currently at a rate of \$0.30/acre for every acre of land enrolled under Wisconsin's County Forest Law, a rate set back in the 1980's. In addition, counties are statutorily required to return 10% of gross timber revenue (an overall system average of \$1.25/acre) to towns containing county forest lands. Individual county board may elect to go beyond the 10% that is required, and some do.

The Department of Natural Resources makes payments to towns containing state forest lands at a rate of \$.88/acre for lands acquired prior to 1969; \$1.87/acre for lands acquired prior to 1992; and \$2.41/acre for lands acquired after 1992. Beginning in 2001, state lands purchased with Knowles-Nelson Stewardship funds receive PILT payments at the rate equivalent to taxes paid on the parcel prior to purchase by the state. Furthermore, there is no requirement to return any percentage of State Forest timber sale revenue to towns.

**CURRENT STATUS:** Under the current Acreage Share Payment/PILT system, towns are paid at a much higher rate for state forest lands than county forest lands. In general, the public and the towns do not make a distinction between the uses, benefits, and economic impacts of a state forest versus a county forest, and it would be appropriate to compensate the towns on a more equal basis for county forest lands. In light of changes to the shared revenue system, it is important to ensure public lands, including county forests, do not become an economic burden to local governments.

**RECOMMENDATION:** Increase the County Forest Acreage Share Payment to \$0.60/ acre. An increase is long overdue and has not kept up with inflation. Coupled with the severance share payment from the counties, this would make the relationship between state PILT payments and County Forest Acreage Share Payments more equitable.
