C. <u>DHS Grant Opportunity for Youth Crisis Stabilization</u>

Members recognize that the work to implement the Youth Crisis Stabilization services required under the grant would place considerable strain on NCHC staff resources. Generally, all members express support for application of the grant; however, members express a desire to identify Social Services staff to support NCHC staff in further exploring the grant opportunity.

Action:

Follow up:

Marathon County members to identify point person from Marathon County DSS to assist NCHC in further exploration of the grant application. Marathon County members to seek assistance/input from Langlade and Lincoln if necessary

Loy to reach out to State to ascertain if NCHC is still able to apply for the grant and Loy is to reach out to do initial search for potential real estate sites for a Youth Crisis Stabilization facility.

4. Educational Presentations and Committee Discussion

A. Update on Jail Alcohol and Other Drug Abuse (AODA) Assessment discussion

Discussion:

Chair Leonhard indicates that Marathon County staff are convening a meeting with representatives from Marathon County Probation/Parole and ATTIC Correctional Services to identify a mechanism for AODA assessments of individuals incarcerated in the Marathon County Jail. The solution identified in Marathon County may be of interest to Lincoln and Langlade County.

Consensus amongst members is that NCHC has not been designated as the responsible party for this service by the RCA and is not being tasked with do so at this time.

Follow up:

Marathon County to update partners as to the result of its ongoing efforts to identify a mechanism for these assessments.
