B. Application for Program Creation/Substantial Modification – Alcohol & Other Drug Abuse Assessments in member county jails

Discussion:

Scudiere explains the nature of the staffing issues that have impacted NCHC's ability to deliver AODA assessments in the respective member county jails. Leonhard and Billeb explain their understanding of the genesis of the need for these assessment, namely that Probation/Parole utilizes them as a tool to make determinations regarding suitability for incarcerated probationers relative to Alternatives to Revocation. Bergstrom raises questions whether Lincoln County is impacted by this change, as her conversations with local sheriff's office personnel have led her to believe the impact is not significant. Stowe references conversations he has had with the District Attorney in Langlade County. Consensus emerges that the approval of the application at this point is premature and additional follow up is needed.
